**RSU 54/MSAD 54**  
**PARENT INVOLVEMENT POLICY**

**PART I. GENERAL EXPECTATIONS**

The RSU 54/MSAD 54 agrees to implement the following statutory requirements:

- The school district will put into operation programs, activities, and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating children.
- Consistent with section 1118, the school district will work with its schools to ensure that the required school level parental involvement policies meet the requirement of 1118(b) of the ESEA ,and each include as a component, a school-parent compact consistent with section 1118(b) of the ESEA. The school district will incorporate this district wide parental involvement policy into its LEA plan developed under section 1112 of the ESEA.

4. 5. The RSU 54/MSAD 54 will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A schools. 1. The RSU 54/MSAD 54 will build the schools' and parent's capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, through the following activities specifically described below:
  - A. The school district will, with the assistance of its Title I, Part A schools, provide assistance to parents of children served by the school district or school, as appropriate, in understanding topics such as the following, by undertaking the actions described in this paragraph-
    1. the State's academic content standards,
    2. the State's student academic achievement standards,
    3. the State and local academic assessments including alternate assessments,
    4. the requirements of Part A,
    5. how to monitor their child's progress, and
    6. how to work with educators:

1. *The State's academic content standards are addressed through each grade level's curricula. Parents are informed at the parent/teacher conference of specific expectations. Progress reports continue to inform parents of their student's progress in meeting content standards.*
2. *The State's academic achievement standards are reflected in district level assessments. Parents receive student results and proficiency levels as part of PAAP, State Assessment, and Fountas & Pinnell Benchmark Assessment.*
3. *Qualifying students will be given the PAAP as outlined in their IEP.*
4. *The requirements of Part A, as outlined on the first page of this document, are outlined and reviewed with parents at the annual policy review meeting. Each Title IA school is required to have an updated Parent Involvement Policy which outlines specific Part IA activities.*
5. *Parents are able to monitor their student's progress with trimester progress reports, parent-teacher conferences, phone calls, and emails. Parents of students in grades 4-6 are able to monitor grades through PowerSchool.*
6. *Parents receive a letter each September encouraging parents to volunteer at their student's school. This letter also outlines the procedure for setting up classroom observations with school and teacher contact information provided. Parents are able to access teacher email addresses from individual school websites.*

*Read 180 training and technology, Responsive Classroom Training, Maine Partnership in Comprehensive Literacy continued professional development, Reading Recovery continued professional development, Fountas and Pinnell literacy assessment training, AIMSweb training, Response to Intervention professional development, literacy coaching and math coaching.*

- B. The school district will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:

*The RSU 54/MSAD 54 Parent Outreach Coordinator responds to fall and spring parent surveys to supply the needed support as listed above.*

- C. The school district will, with the assistance of schools and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out

to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

*RSU 54/MSAD 54 supports parent-teacher conferences, school counselors, parent/teacher organizations, teacher and principal newsletters, telephone calls, and email messages to build ties between parents and schools.*

D. The school district will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

*Coordination between RSU 54/MSAD 54 and the KVCAP administered preschool program insures parental involvement.*

E. The school district will take the following actions to ensure that information related to the school and parent- programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

*Building principal and teacher newsletters are sent home, attention is given to make the message understandable and uniform. School news is relayed verbally and if necessary the English Language Learners (ELL) teacher contacts parents.*
